



**2018 Krispy Kreme Challenge Fun Run  
Sunday, May 20 at 9:00 a.m.**

- The Fleet Feet Sports Krispy Kreme Challenge Donut Run is a fun event for runners and walkers of all ages.
- Participants will run/walk a one mile loop in the neighborhoods around the store 1, 2 or 3 times and will eat a Krispy Kreme Donut on each lap. You will receive a Popsicle stick after eating a donut and after completing a lap. The first 75 people to turn in SIX Popsicle sticks (representing three miles and three donuts) will receive a prize.
- Due to growing participation and to ensure we have enough donuts for all participants this year we are charging a minimal race registration fee: \$2 for adults and \$1 for children.
- Participants will be required to check-in from 8:30 a.m. - 9:00 a.m. at the store before the race to pick-up a race bib.
- For a \$5 donation to St. Jude participants may skip ONE donut. Make your donation at bib pick-up.
- Course time limit is one hour
